Following a wedding, clean-up must be completed by 1:00 p.m. the following day

<u>Prohibited conduct</u> (non-compliance results in forfeiture of security deposit)

Burning of candles or open flame INSIDE The Barn

Any violations of local, state, or federal law (No Alcohol served to MINORS)

Theft, removal of, damage to any personal property of Lessor

Non-supervision of children by a responsible adult, especially around the fire pit

Use of nails in the venue or outside; zip ties are to be used for hanging objects

Confetti inside/outside the venue is prohibited
